



## Frequently Asked Questions

What primary photographic style do you identify with?

Lifestyle and Photojournalism.

Do you offer special techniques such as hand-coloring or toning?

All images are edited in color. Any special request such as b&w, sepia or hand-coloring are an additional cost to be determined by project.

Do you have experience shooting in various lighting situations?

Yes, all lighting.

Is your media preference film or digital?

All digital.

How many photographers do you work with?

I have one assistant photographer that works weddings with me.

Do you guarantee your presence at the actual event?

Yes, unless a uncontrolled situation prevented me from being there.

Do you have a replacement photographer in case you become unavailable on the day of the event?

I always have a backup of photographers I know.

What kind of equipment do you bring with you on the day of?

I keep it simple. I bring an off camera flash, extra film, lots of batteries, variety of lenses and extra gear just in case. Always plan ahead.

What is your policy on taking breaks? If you require a meal break, do you require that the client provide your meal?

We do ask that you provide a meal. In the event that you don't we would take up to an one hour meal break and may leave the premises.

How soon after the session or event are the proofs ready for viewing?

The edited files will be ready in approximately eight weeks after the event.

**Do you provide the digital files and/or negatives (or copies of the negatives) to the client?**

Yes, if purchased.

**In what format are the initial proofs offered?**

If you purchased the Digital Negatives they will be available for three months in your online viewing gallery. You may share this gallery with anyone. You will also receive a DVD if purchased. We shoot in camera RAW format. That being said, our policy is that we never give out unedited images or RAW images.

**Do you retain the copyright for the photos?**

Yes, always. If purchasing the Digital Negatives you will have printing rights and may make as many prints as you wish for friends and family for personal use only.

**Do you reserve the right to publish the photos?**

Yes. My images may also be used on my website, marketing material, greeting cards, book covers and anything I see deemed fit for my business or to promote my work as an artist.

**Do you offer albums?**

Yes! Ask me and I'll show you some beautiful sample albums that I'm sure you'll love.

**What is the process if I order an Engagement Album, Wedding Album or Guest Book?**

You choose the images you want and the style you love and I'll custom design it just for you. Design time can take 2-4 weeks depending on the season. I'll show you a digital preview right before sending it to the lab.

**When will I get the final album?**

Depending on the company and their backlog it could be 2-4 months on average. The sooner you supply the images for the album the sooner I can start your project.

**What are some other products you offer that could help me with my wedding planning?**

I offer Engagement Sessions which is the perfect time for a test drive with me and you get the Digital Negatives which can be used for printing images for display on your wedding day. I also offer Save the Date Cards! Ask me to show you some, you'll love them! Or maybe having a beautiful Guest Signing Book or Engagement Album on display at your wedding is more your style. Either way, we've got you covered!
